By-Laws rewrite project

The President, Vice President, and Secretary/Treasurer are working on a revision to the club bylaws (the current version is dated 2012). John Shea is preparing a draft. At the March meeting he discussed his proposed changes to the Preamble, Article 1 (Mission), Article 2 (Name), and Article 3 (Membership, Dues and Fees). A review of the remaining articles will be handled in two subsequent batches.

The membership agreed with most of his proposed language. There was some discussion on the requirement in Article 3, Section 6(a) to have some officers be members of the National Field Archery Association. There was also discussion on membership renewals and family memberships. He will take the comments into account and prepare another revision which will be formally presented at the April membership meeting with the intent of getting approval to send it out to the full membership in an email. The email will announce that a vote will be held on the changes at the May membership meeting. This email notification will be separate from the newsletter email to help ensure awareness and give members at least a month to review.

Any changes will be done pursuant to Article 9 (Proposed Amendments) of the by-laws. That Article describes the process for making amendments. A proposed amendment must be presented in writing at a regular meeting. It must then be tabled until the next regular meeting. In the interim, the Newsletter must report on the proposed amendment and its effect. It will then be voted on at the next meeting. An affirmative vote of two-thirds of the voting members present is required to amend the by-law. More to follow on this important project.

Fairfax County Park Hunts --

Qualifications for the next season will run from March 21 – June 20. Qualifications for the program now must be done on an **annual basis**. Qualification sessions will be held at NORVA. There are only three clubs that do the qualifications, so we may be busy.

<u>International Bowhunter Education Program (IBEP)</u> – This class is required to archery hunt the Fairfax county park program as well as on Fort Belvoir. There are multiple places to attend this course. They generally run about 8 hours and are conducted mostly on Saturdays. See link below to find a class in your area. You only need to take this class once (good for life).
