Message from the Board

As required in NORVA's by-laws, this Newsletter is a report to the membership of the Board's actions. It also constitutes the minutes from the October 2021 meeting.

General Items

The October 2021 meeting was held both in-person and on-line. It was led by President Joe Wolfe.

•<u>Fees for 2022</u>

There was a discussion on the club's membership fees for 2022.

The proposal is to have the membership fee be \$150. For those members who renew before February 1, there will be an early registration discount of \$30.

A vote on this topic will be held at the November club meeting.

•New laptop for the club

John Shea proposed that the club purchase a laptop to replace our aging desktop. It will be kept in the safe. We can take it outside (e.g., for orientations) and move it around if needed. This would fit on the club's administration desk. The budget for this is approximately \$1,000.

•On-line voting

The club is looking to allow for members to vote on-line on issues that are raised at meetings. Web Master Uwe Jacobs will be able to generate a personal information number for each member. They would use that number in voting. Look for future announcements on this initiative.

•September Newsletter

The September newsletter reported on the VBA vote. It also stated that Joe Wolfe resigned at the end of the September meeting following the vote.

The newsletter should have instead said that Joe informally verbally told the VBA president of the final vote outcome on September 10 (not on September 12, as reported in the Newsletter) as a courtesy. The formal notification was signed and sent by John Shea, per the order of

succession defined in the NORVA bylaws, Article 4, Section 1. In hindsight, John should have signed the letter as acting president, since the club Vice President was not able to complete the action in a timely manner.

Because most board members felt that Joe had made a rash decision (it was a long day for many), we wanted to give him a chance to change his mind before reissuing a call for 2022 president nominations and holding another election. He decided to do so, thereby remaining as President for the remainder of his 2021 term. He will also continue in 2022 as President.

Field Course (Ken Wilkinson)

We have lots of block targets to put out. We will be conducting field course maintenance over the remainder of the calendar year. Beginning on November I will install two new layered foam targets per week, with work being completed between Monday/Friday in order to not inconvenience club members on the weekends. Replacing two targets typically takes around five hours depending on whether the target frame needs rehabilitation.
