## **Message from the Board**

As required in NORVA's by-laws, this Newsletter is a report to the membership of the Board's actions. It also constitutes the minutes from the February 2022 meeting.

## **General Items**

The February 2022 meeting was held on-line. It was led by club President Joe Wolfe.

### Covered shooting area.

We have cost estimates for construction of overhangs for the practice range. President Joe Wolfe will meet with Fairfax County officials to obtain the requisite permits. He and Ron Meinert will then put together a plan to present to the club. We hope to break ground on the project once the weather warms up.

### Clubhouse maintenance

There is a medium/large rodent currently residing in the clubhouse ceiling. It was last heard scurrying over the desk area. We are investigating ways of trapping or exterminating the pest. There are areas of the eaves that this animal may have used to intrude into the ceiling. We plan to repair the eaves with new screen and wire mesh once the rodent has been removed.

Joe Wolfe recently rebuilt the paper tuning stand in the clubhouse. Unfortunately, it appears that someone has already shot the stand and broken the pipe at the top where paper feeds through. While accidents do happen, we do ask that club members report these incidents to club leadership so that they can be addressed.

### **March 19 Work Party**

We will be holding a work party on Saturday, March 19 from 8 a.m. until noon. The focus of the event will center on dismantling the old outhouse building, as well as stacking and sorting the myriad old target materials adjacent to the storage shed. If conditions permit, we will also repair the clubhouse eaves. ## **Field Course** (Ken Wilkinson)

The field course has been cleared of all downed trees and limbs from these last winter storms. There are a handful of bow hangers that have either rotted at the base or were knocked down over the winter. The stands will be replaced in March as part of ongoing maintenance. As of the end of February, all 28 targets on the field course have fresh target faces and the course represents a complete “field round.” The next iteration of targets will include a half “hunter” round of 14 targets.

## **Membership** (Gerry Petraitis)

The club already has 516 members. We may break last year’s membership record of 661 members.

An orientation was held on February 12. We had 25 primary members and another 23 family members.

The club took in \$29,000 in January, primarily due to our large number of membership renewals. There was also some income generated by sales of the club's new merchandise.

The club has budgeted \$3,500 for the field course, \$2,500 for Academy improvements, and \$4,000 for 3-D targets and inserts. We have purchased new 3-D targets.
