# Message from the Board

As required in NORVA's by-laws, this Newsletter is a report to the membership of the Board's actions. It also constitutes the minutes from the March 2024 meeting.

## **General Items**

The March 2024 meeting was led by President Ken Wilkinson.

### Phone service at the clubhouse

There was a discussion on whether to get a phone plan that would allow the clubhouse to have internet service. Ken indicated that he would check with the Fountainhead Park office to see what service they are using.

### **March Work Party**

The Club's first work party of 2024 was held March 3. We had approximately 20 volunteers show up to help. Thanks to everyone who pitched in, we were able to get the 3-D course prepared for the upcoming club season. Our 3-D Course Captain has laid out a number of challenging targets. Everything is scorable, but you will be challenged to make a "10" on many of them.

## **Hunters for the Hungry Shoot**

The Belvoir Bowhunters asked to move the date for the Hunters for the Hungry Shoot that they host at NORVA. It is currently scheduled for August 24. This presents a conflict with another shoot in Virgina. Belvoir would like to move the shoot to August 10.

## **New Handwashing station**

The Club recently installed a hand-washing station.

### **Equipment Maintenance Bench Drawboard Accident**

Recently, a member experienced an equipment failure when utilizing the Last Chance Archery drawboard (located on the left side of the maintenance bench). The cord that connects the drawing mechanism to the bowstring broke, resulting in the aluminum pulley launching through the arrow rest. Fortunately, no one was injured, and the only damage was to the equipment. The drawboard has been replaced with an identical model as the one on the right side of the maintenance bench. It is imperative that members utilizing the maintenance equipment inspect for serviceability before use.

## **Academy** (Dave Grant)

Academy Classes started on March 16. This year the Academy will try to include in the classes a session where the students walk the 3-D and Field Courses.

The Academy would like to hold classes on days that the Club is also holding a shoot. This will expose the students to the atmosphere of the shoot experience.

Jordan is working on a spread sheet to track all the inventory for the 3-D range. He is also preparing a request for targets and inserts. This year the Club will purchase 3-D materials directly from the manufacturer (Reinhardt). In the past we have purchased through an archery store. Buying through a store can be slightly cheaper, but it results in delayed delivery, as the store waits until it gets orders from a large number of local clubs before making its purchase. By buying directly, NORVA will have more control over when we get delivery.

The Club needs a Tournament Chair and a Field Course Captain. Please contact a club officer if you are interested in helping out the Club while having fun. Ex-President Joe Wolfe has agreed to fill in as Tournament Chair on a temporary basis, until we find a permanent Chair.

John is waiting for prices on big-ticket items such as 3-D targets and lights for the practice range. Once he has those, he will be able to prepare a budget for 2024.
